All shares have been bought by our CEO Mr. Roger Van Poyer and his company Helear Unip. Lda. This company already owned the old albergaria next to Vila Sra da Rocha which is now being converted into a large mansion house.

Mr. José Pereira has relinquished all his powers and is no longer involved in Marrocha's management. He will be succeeded by Sandra as manager (Gerente)

We realize that there are debts to owners. We will approach everyone personally and will find a solution together. In any case those debts remain. We also know that there are outstanding's from owners to Marrocha. Here too we would like to negotiate and resolve matters positively.

Our intention is to give Vila Sra da Rocha a major upgrade. Houses need to be painted, better garden and street maintenance; A lot of apartments must be given a new and clean look inside and outside; we want to create more open spaces, greener; Re-do the entrance. We will ask owners if they are willing to renew their house/appartement and we could help financially if needed.

VSDR must become beautiful and attractive again. Not only will this benefit rental, but its reputation will grow. We would like to double the value of all properties within a few years!

We cannot do this atone! We therefor appeal to all if are willing to help us. Let us have your ideas, suggestions but please allow us also some time. Rome wasn't built in one day either.

We will communicate now real closely with you as an owner so this week we will send another email with the more specified plans/planning of all the improvements/changes.

So, we have been busy for a few days and started to clean up the rubble ...
literally and figuratively!

What are our first plans and proposals?

- Review all existing contracts and discuss together if necessary
- To determine Marrocha services, including reception, and make them available exclusively to its members
- Draw up a new budget every year and discuss it together where and if necessary
- Change the current system of access restrictions. We opt for the system of badges that give access to the swimming pools and exit / entrance towards the sea
- Open mini golf and tennis courts freely and free of charge for owners and their potential tenants who have a cooperation contract with Marrocha • Gardens that have not been maintained for any reason will be cleaned up
- Provide stewards for more safety both when driving in and at the pool • Mini market only for owners and tenants.
- First clean up the entrance and the parking next to it, repair, paint ...
- Adjusting publicity and breaking off excess
- Creating a website only for owner and management Marrocha in which all possible problems can be addressed (login)
- Create a new custom website for / from Vila Sra da Rocha. Create greater appeal to attract a better class of customers + channel manager
- Carry out the most urgent outdoor paintwork (e.g., old restaurant building)
- Cleaning up the mess behind the buildings
- Repainting apartments, renewing what is needed (possibly kitchens, sanitary ware, furniture) to promote the rental.
- Buy a defibrillator

Some changes of policies:

We regularly see people from outside, non-owners' non-tenants. Some of them even asking facilities at the reception (e.g., going for a swim ...)

We see brokers, visitors for unknown reasons.

We would like to stop this wherever possible. Vila Sra da Rocha belongs to the owners.

Already now we make a huge appeal to all owners who have no contract / contact with Marrocha. Please join us. This new Marrocha can and will give you a service you will not be able to find outside.

I ask you respectfully, please participate in our costs. More income => more investments, more facilities ... (we are hoping for e.g., a spa, a gym, massage room, other playground, entertainment ... but we need the means to do it!

All together we can make our village unique.

We need all of you to help us to do it!

Letter of CEO Mr Roger Van Poyer 18/07/2021

Good morning, Vila Senhora da Rocha

Hope this website note finds you all in good health.

So, let us recap the content of our previous letters:

- We have cleaned up the most needed gardens and continue to repair the others
- We are completely renewing the laundry area — new wash/dry and ironing equipment. You and your tenants will be able to request this service (against costs). Planning to create a drop off area.
- The entry of Vila Senhora da Rocha is completely renewed (repaired and painted). Have already repainted a lot of walls, houses/apartments including the old O Forno restaurant and more will follow.
- Repaired a lot of water connections, drains, electricity in so many places. • We are renewing/decorating the pool restaurant; we have and are building a new professional team.
- Bon Appetit and by the way we now have Portuguese beer, new menu and better wines ...
- Re organized the reception, new modern computer system, meeting room.
- Tennis is free to owners/tenants. Contact reception
- Container mini market was costing a lot of money, so we stopped this partly for the time being. Bakery is moved to the restaurant area and later we will re-open the mini market where it was before.
- Stupid publicity mostly removed.
- Key collectors installed at reception.
- Defibrillator installed at reception.
- We are repairing the border fences to avoid non-residents to come in, also put some alarm spots.
- Have negotiated with the camara de Lagoa about the trash cans — we will get the new system (all separated and build into the ground) but it will not be before

September 2022, therefor we still consider to build a metal wall in front of the big trash cans to take the ugly view away and create more parking space. The public ones will move to a nearby location.

- Soon the new system of entry pool and beach gate will come into service.

Contact reception

- We made a new relax/sitting corner behind the children playground — furniture to arrive soon.
- The children playground will move to another well-protected plot with new equipment. We can then use the area for other purposes — maybe you have some ideas?
- Beautiful Art will appear in our village, and we will also construct social areas.
- We bought electric buggies for the reception and the cleaning staff to serve you better and more quickly.
- We have added 6 more cleaning/laundry staff, bringing the total to 10 ladies!
- Cleaning up of some forgotten areas is on the planning but shall have to wait a bit longer.
- Several appartements have been completely renewed (furniture, painted, redecorated, if interested to visit one of them — just let us know.

Well, you can see for yourself what other constructive changes are happening!

What else is new? Our official / public website is live: www.vsrocha.com or www.vilashoradarochaportugal.com (still) under construction as direct booking must be added)

We believe it is great with new lay out, pictures etc. - for sure it will generate more, and higher-class clients (paying more) Clients will soon be able to book directly the house, villa or apartment they prefer.

Our own site (Owners vs Marrocha and v.v.) - www.marrocha-algarve.com We can communicate directly, so let us have your feedback, comments requests ... Correspondence can in Portuguese, English, Dutch (Flemish), Français ... up to you but please never forget that all owners will be able to read these messages.

What are we studying: New path, New irrigation system connected to a desalting installation The day will come that we have beautiful green grass everywhere.

Create more open space for socializing, install (stone) tables/seats where one could play chess, backgammon

Space for entertainment, events, social gathering.

New direction signs

Security cameras have and other will be installed at various locations mainly pool and beach gate. More to come ...

Enough for now.

Thank you for reading my letters and many thanks to so many people overwhelming us with nice compliments.

The credit for all the works already done have to go to Mrs. Sarm (Sandra Moors) our Gerent, to Sr. Joao (Jan Vanhex) for all outside works and to Mrs. Sandra De Vree for decorating the apartments. Ladies and gentlemen,
Dearest owners,

Welcome and we hope that most of you are happy that we managed to have this meeting.

I am Roger Van Poyer owner and co-manager of Marrocha and at your service!

I will do my explanation in English and Donna Paulo will repeat the same text in Portuguese.

Eu farei minha explicação em inglês e a donna Paulo repetirá o mesmo, texto em português

We feel you should know that Marrocha would not exist anymore if we would not have taken it over. Marrocha would have been bankrupt – basically it already was – maybe it still is

For your information:

We found, after the takeover, very important outstanding debts from the past, for a total of approx. 1.000.000€ concerning loans; social security, suppliers, and most important debts to owners with rental contracts. We have already paid back the loans made by the previous management which were at + 4 % to an actual interest of 0.5% but nevertheless we must pay these debts.

We are still having problems with accounts – some invoices were not issued for unknown reasons– Some may have been issued but seem not to be recorded – Presumably or shall I say hopefully, owners who paid the condo fees did receive a receipt for the payments of 2021.

We will contact all of you to find out exactly which bills are still outstanding, and which have been paid. All must be straightened out. With us, everything shall be 100% honest, official, and legal.

Very important item. Contract Q1.

Here we talk about the debts Marrocha has to several owners.

First, please be assured that we will pay these outstanding, but it is at this stage impossible to do that in direct payments.

We did not even know that owners were not paid in 2019. We hope you can understand that we cannot consider 2020 due to the impossibility to rent whatever due to the covid period.

We already have agreement with many owners to settle the debts from 2019 and 2021 through renting their apartment based on a new fair contract. Others we will redecorate, and or refurnish their property and pay back the debt that way. Owners who we could not meet yet please contact Samm to discuss your financial position and to find an acceptable solution.

But please do not worry about all these problems. We took over and we are trying our very best to safe this great village and to give you the best service since its existence

Talking about rental services let me pass on the floor to Samm who can explain you in detail what we can do for you.

You should know that this management is working for free, at least until we solve the financial difficulties. Also, the investors do not get any return on their investment nor interest on their loans made to Marrocha. More, all monies earned by Marrocha through renting, cleaning etc. will be used to pay off the debts and to invest in the future of our village.

Enough of these matters, let me talk about the future.

First about future investments

We are studying a project of desalting water from the sea and use this for all our gardens and possibly drinking water to all houses. As soon as we have a realistic proposal, we will contact you to see whether the majority can and will approve this rather expensive investment. At least we can start dreaming about fantastic green gardens everywhere and throughout the year. This investment included also a completely new irrigation system which should be renewed after all these years.

We are also seeking the best solution for our walking paths between all buildings. We have about 4 km of path until each doorstep_but once this is done it will be beautiful, practical and it will increase the value of our village. We are considering the possibility of concrete, calçada or asphalt to cover all paths.

We will come back later the tennis courts but can already inform you now that the one court behind the old O Forno will remain closed for

now. About the others the owners will be consulted via our website when we reach the point of decision

Same about the mini market – we consider putting it back to its old place - details later when final decision must be made

We have been working on the cleaning up places like the water treatment area and the storage behind the reception, in fact the entire domain. As requested by some owners I can already now confirm that the old storage next to the water treatment house has been emptied and will be broken down soon.

An additional note and rather important. If you have any modifications done to your property, please instruct your builder not to dump his rubble. Another point you should instruct your builder is not to dump their rubble next to the containers which they place on the parking spaces and to clean it up.

About the covered pool, same problem. We are calculating the exact costs of keeping it covered and heated. We estimate it at 15.000€ for the winter period. Soon we will consult the owners by online vote, to know what their preference.

Another investment we consider are extra sunbeds and new fixed rotan beach umbrellas. Again, we will consult you later this.

Last summer we noted that good maintenance of the pools is an absolute must. We also plan a lifeguard during summer period, not only for safety, but also to avoid people reserving chairs for the all-day thus troubling other owners and guests. Cleaning ladies will keep the toilets fresh and clean during all day and evening.

Children playground. The one we have today is outdated and even dangerous on some points. We are looking for another space for the kids to enjoy themselves and to help the parents to get some more rest

To stop previous bad comments and bad arrangements it was necessary to change the old names

Our new names are from now on: Vilas Marrocha at Senhora da Rocha and Aquaresto for the restaurant.

The change of name is purely commercial meaning that the location name remains Vila Senhora da Rocha.

Restaurant is being redecorated allow me to call it rebuilding, by painting, covering the terrace and with nice lights, new floor inside/outside and I presume most of you already saw the new entrance which will be opened later at 7 pm – All should be ready hopefully by December latest January. Hope you will like it as we hope you will appreciate the new qualified chefs, the restaurant manager, the new maître de salle and the rest of our team.

Later, Samm will present all our responsible to you.

One last point about the restaurant, it will also be open to owners for private parties, events, or business as from January

About our laundry. We installed completely new equipment for over 50.000€. We bought new linen for 15.000€.

Our laundry is now also available to all owners, weather renting or not.

About the infrastructure of the domain. Let us start with the garbage. We have the promise from the city hall that they will install a new garbage system in the ground, foreseen in September 2022.

The internal garbage collection is now also being done during the weekend thus avoiding the problems we had with seagulls and cats.

As you have seen we installed barriers for safety and to keep people not belonging to our village outside as lots of people parked their cars inside our premises to go to the beach.

There has also been misunderstanding about the road and parking's. We have an official document from the city hall stating the road inside the village belongs to the city hall but is private, meaning that it is our responsibility.

Also, a quick word about the storage. We had to move a huge number of packages from the laundry to a new storage place. Not only for hygienic reasons but also this is not a service we can continue to provide. May we ask the owners who still have personal belongings in storage to remove them as soon as possible. All items not collected before summertime will be disposed of.

A word over the old O Forno restaurant. A lot of history for the older owners but a problem today. We are considering using this space for multifunctional purposes. For example, renting it out for parties, marriages, incentives, meetings etc. This could also attract people from the outside to use our premises, rentals throughout the year. The bar could be a beautiful extra for all of us.

Surely you noted we already did a lot of painting. But for budget reasons we had to put it in stand-by modus. Now if you want your house also to be painted, we will be glad to do it at cost price. Just let Jan know.

One more little item. We are also giving a nice facelift to our meeting room, next to the reception, to receive you in a nice agreeable environment. If owners, clients of Marrocha want to use this space for personal or business meetings, you are welcome to it. Of course, a reservation must be made before.

Before closing this general info, may we remind you our information already sent to you that you can and should visit our newly refurbished apartments and villas. Just give a call to Samm.

Now before starting with the budget 2022, we would like to know if all of you already found your way to our new websites and of course the one, most important, for you, our owners? If any help or more information needed, our general manager Samm is available to explain you everything you would like to know but maybe she can already now explain you what has been done

I still refer to the owner's website. May we presume you already read our letters from the beginning till now? If not, please do. If need be, we can provide you with copies, but please do read them. It is the best way for you to see what we promised, what we did so far and what we intend to do. Your comments, questions, remarks, critics, all can be made directly to us at any time.

Time for figures:

To make it clear: all items below only exist for you to make your life even more pleasant in our village

We tried to get the figures as correct as possible, still, some of them may not be 100%, but we are pretty close

We need some more time to clean up all accounts and find out some more recent and correct costs. The years 2019/2020 have not been that normal but we are sure that before our next meeting all figures will be absolutely 100 % correct.

All questions about the budget will be answered after figures have been noted. Personal items should be discussed with our general manager.

If a proof of any budget costs is requested, we shall ask Mr Maçedo, as president of the owner's association and qualified revisor for him to check the correctness of that costs

We hope you can understand that some figures like e.g., salaries must be treated with some confidentiality

Dear owners,

Where to start?

First, thank you for your attendance at our meeting in O Forno and online and thank you also for your cooperation and for the many compliments we could receive afterwards.

I want to apologize for the little accident we had prior to the meeting. This gentleman is a broker trying to convince members of our village to rent their houses/apartments through his company. The man concerned did not have a legal Power of Attorney to represent any owner.

Owners dealing with him or with other brokers, should realize that they are giving their money away to people outside our village, while enjoying all facilities at Senhora da Rocha. Please remember that Marrocha re-invest its revenue and offers a much bigger, better service and day and night follow up.

The original text of the first meeting shall be put on our owner's website so you can consult it anytime. For your convenience the same text is also included in this folder.

Samm, our general manager and I, ask for a general assembly begin March 2022. Samm shall soon come back with details.

This letter I wrote to explain better what is going on because I have the impression that a lot of you did not yet read our previous notes, therefor this folder which contains all previous letters in Portuguese, English, and French.

Please do read them if you have any interest in your property and in our village.

If you did, I do not have to repeat what has been said and done before, but maybe let me highlight some items.

Maybe we explained our costs not clear enough? Maybe we wanted to go ahead with new (necessary) investments too soon and maybe we should have arranged a meeting before? Sorry for that, but we only tried to do quickly good to the owners, their tenants and for the village in general.

Samm, already had meetings with most of the owners and could come to an agreement for rent and financial settlement. We now try to meet with the remaining owners, if of course they agree.

Directly, we only received compliments and good critics, but some owners made opposition on certain items of our proposal for the service fees, which I repeat once more, are the real and net costs.

Please understand that expenses made by Marrocha, and not being paid back within the maintenance/service fee, shall increase the existing debt.

Indirectly we learned that some owners find the fees a bit expensive compared to 2021. Allow me to respond the following:

- There was basically no real budget in 2021 nor in 2020, 2019 ... I have no idea on what basis the previous management based their requested fee, but I know that it was completely wrong
- Invoices not issued, problems with receipts, cash, transfer ...
- No meetings were held to explain the situation
- Result today is that several owners did not yet pay their fee for 2021.
- Result is that huge losses were made/accumulated and that today there is a debt of approx. 1.000.000€
- Result is that we are now faced with important financial difficulties.

Some owners also questioned the costs for administration (reception, accountancy etc.) I wonder why. No company can live without an administration, and it only exist to give service to Senhora da Rocha.

Furthermore, I found that these costs have always been paid for in the past.

Owners requested us to spend more time and money to the gardens – and so we will!

Owners also requested 24/7 security (guard at gate). Of course, we would agree but these costs cannot be put in the reviewed budget (approx. 70.000€)

Considering the actual status of Marrocha, future important works and costs are necessary. Example: the pumps of all our pools are not working for 75% (nothing was done before to avoid/repair these). The situation is not only dangerous for health but is also illegal and the risk exists that the authorities may oblige us to shut down the pools. If we are to make a professional repair as needed, the estimated costs will be + 50.000€

It was suggested to us that we should create different condominiums for different blocks. This means that the owners of one specific block (example) can discuss amongst themselves what to do more about their building to make it nicer, more attractive. To begin with, they should agree to have their building updated and urgently painted. Marrocha did paint already a lot at their own expense but is unable to continue without financial help.

Now it is up to these owners to help us to further improve the image of the village – indeed some blocks are dirty and ugly and damage the total image.

Looking at the figures above, they may look, at least for several owners, quite expensive, but just consider that we have 243 spaces so it would represent a cost of 473€ each or an increase per month of about 39€ (a onetime investment)

The actual investors, after having put another investment of about ½ a million, are not willing to put more money into the village unless you, the owners, are willing to work together with them, with the only purpose to safe and upgrade Vilas Marrocha / Senhora da Rocha. This is certainly not a threat but the hard truth. We must be able to pay the banks, the suppliers, the salaries, social security, taxes etc. and we cannot do it alone.

We therefor urge you to settle the bills 2021/2022 as soon as possible.

Please realize that the risk still exists that Marrocha could go bankrupt and maybe it is time to think about the possible consequences.
Let us also realize that reducing the budget (real costs) can mean reduced or cancelled services and facilities

The choice is yours!

Other investors are invited - if you would be interested, just let me know.

This management is doing its utmost to make our village beautiful again, in perfect working conditions, modernized, financially healthy, create a high standard of service with the one single aim to increase the value of your property, thus getting better (paying) clients and also create a happier environment.

On the last page of this letter, you will find a questionnaire which we would like you to vote on. It will be collected at the end of the general meeting and the result will define future decisions.

A little remark:

The average fee (example a T2 apartment) is 180€ per month. (Based on first budget) or the price of a few meals ...

Where else in the Algarve can one get such a location, so many facilities and such a service for that price.

And if you consider renting your property through our channels, you shall recuperate the maintenance fee very quickly and make a nice profit at the end.

Have another look at our professional rental brochure for the outside world. By allowing Marrocha to handle your property, you also invest indirectly in Senhora da Rocha and all your worries are taken care off!

I realize I sometimes repeat myself, but this is only for now. Once the train is back on its rails, I will not have to convince you anymore about anything

Coming up:

A new general brochure promoting the apartments available through Marrocha

A new rental brochure to the owners

A new brochure for the restaurant

A new brochure for guest only

Nevertheless, after all what we said and did, and after a willingly study and considering the remarks and wishes of owners we decided for now to bring the total costs of the budget down to 450.000 €, which represents a reduction of + 22%

(Repeating the example of a T2 apartment, it will now be approx. 140€ per month. Is this worthwhile the risks, the difficulties, the appreciation of our work ...)

If these adapted figures are accepted, the service fees will be corrected pro rata.
